As a result, we're excited to be rolling out our electronic funds transfer and virtual card payment solution.

Enrollment for the services will begin on **December 13, 2021**. Our EnrollSafe EFT enrollment hub is easy, safe, secure, and available 24-hours a day.

Beginning November 8th, 2021, log onto the enrollment hub at enrollsafe.payeehub.org to enroll in EFT. You'll be directed through the secure portal to the registration page, where you'll provide the needed information to establish a registered user account. You'll then be guided to complete the banking enrollment process, where you will provide the information needed for direct deposit. EFT deposits will begin as soon as the necessary identity and banking information has been validated. Monitoring the progress of your EFT enrollment is easily accessed in EnrollSafe.

For your convenience, we always recommend you register for EFT at the TIN level. Enrolling at the TIN level reduces your administrative burden, as any new providers added to your practice or organization will automatically be set up under your existing EFT enrollment. If you have registration-related questions, EnrollSafe has Help Documents and phone numbers conveniently located on their website.

Enrolling in EFT will help streamline operations and reduce administrative costs. Consider these benefits:

- Reimbursements are deposited to your account faster.
- EFT payments don't get delayed or lost in the mail.
- EFT payments are more protected from fraud.
- Bank fees are lower.
- You save time with fewer trips to the bank.
- You save money by reducing your associated labor and cash security costs.
- You can easily access your remittance advice online.
- Transactions can be posted to your system automatically.

We will also offer enrollment in electronic remittance advice (ERA). Registration for ERA will be via the Availity Portal at <a href="https://www.availity.com">www.availity.com</a>. Explanation of Payments (EOP) 835 will continue to be retrieved via the HealthSun Provider Portal <a href="https://provider.healthsun.com/">https://provider.healthsun.com/</a>

If you are currently receiving virtual cards from other payers, you may begin to receive your HealthSun payments in the same manner. Virtual cards allow your office to process payments as credit card transactions. Your office will receive a letter containing a virtual card with a number unique to that payment transaction. Once the number is received, you simply enter the code into your office's credit card
